2. Site fees are not refundable unless the event organiser manages to sell the said site.
3. The event organiser reserves the right to alter or adjust any details or organisation relating to the event without notice or prior warning being given to the exhibitor.
4. The use of video, TV and microphones are permitted. However, sound levels **MUST NOT** disturb other exhibitors. The event organisers reserve the right to terminate the use of such equipment at their discretion.
5. The exhibitors display must fit inside the allocated site area. Tent guide ropes and display material must not be outside the allocated area.
6. No subletting or multiple occupancy display will be allowed without the event organiser's permission.

7. Not all sites have electricity. All sites with electricity are marked on site diagram. Where electricity is provided it is 10amp 240V only. All leads/power boards must be tagged by a qualified person. The exhibitor is to supply own leads/power boards.
8. **NO EXHIBITORS ARE PERMITTED TO DISMANTLE THEIR DISPLAY PRIOR TO 3.00PM SUNDAY.** Your registration is a contract committing you to the full two days of the event.
9. Night caretakers will be on duty from 5.00pm till 9.00am. Friday to Monday.
10. All exhibitors are to comply with the Occupational Health and Safety Legislation. The event organiser reserves the right to inspect all exhibitor sites to ensure compliance of the Occupational Health and Safety Legislation.
